COVID-19 Rules

COVID-19 RULES WERE LAST UPDATED 6/29/2021. PLEASE READ LATEST VERSION OF THE COVID-19 RULES. ALL PARTICIPANTS AND SPECTATORS MUST WEAR A MASK OR SHOW VACCINE CARD. Complete COVID-19 Rules are available on the Barn Hunt website. Participants are required to have read and abide by the COVID-19 Rules. All participants and spectators must sign a COVID-19 waiver when they arrive.

No entries will be accepted between the Late Registration close date (9/22/21) and the day before the trial event. All entries after 9/22/21 must be done in person on day of trial.

Permission has been granted by Barn Hunt Association, LLC.

Barn Hunt is open to all breeds and mixed breeds of all sizes. Dogs must be 6 months of age or older to compete. Dogs must have a Barn Hunt number to enter. For a complete copy of the rules or to register a dog, go to

www.barnhunt.com.

At all times, the safety of the dogs, handlers, and rats, is to be of paramount importance. At will be humanely handled and safely confined in aerated PVC tubes. Barn Hunt is not intended to harm or kill rats.

Grounds open at 7:45 am. Please do not arrive before 7:45 am. Grounds close 1 hour after last dog runs.

- Judge of Record and Event Official dogs may be judged prior to the official start time or as the first blind(s) of the Event.

Notice to Exhibitors

- 🐾 **Valid Entries** – A valid entry must be submitted to process entry. Entries are not valid for the following reasons: unsigned, no payment, incorrect payment, wrong information, incomplete information, to name a few. Complete list of reasons can be found in the Rules on www.barnhunt.com. Invalid entries will be notified and not processed until all information has been completed. Entries are not valid unless signed.
 - Please follow the steps on this [link](#) to correctly fill out an entry using the “online entry” on the BHA website. (form available on the Canine Adventures website under “Resources”)
- 🐾 **Payment** will be processed when entry is received, i.e.: cashing of checks, run payment, etc.
 - **Non-Sufficient Funds** – All payments returned with NSF will be subject to a \$50 fee.
 - **Checks** are made payable to Canine Adventures.
 - **PayPal** available. Please add \$1 per run for processing. To request an invoice, email Info.K9Adventures@gmail.com.
 - **Day of Show Payments** – Cash or checks only.
- 🐾 **Entries/closing dates**
 - **Entries** - will be considered “on time” if postmarked by the entry closing date posted in the premium.
 - **Day of Show (DOS)** – Entries presented to the trial secretary on the day of a trial event during registration/check in.
 - **No entries will be accepted between the Late Entry close date and the day before the trial event.**
 - **Entries received before the open date will not be considered.**
- 🐾 **Confirmations** – Confirmations will go out in the form of email. Please print your email address clearly.
- 🐾 **Rules** - It is the handler’s responsibility to read and understand the rules in the **Competitors Rule Book**. Rule books can be found on the Barn Hunt Association website.

- 🐾 Dogs may enter both **Instinct and Novice** in the same trial until the dog has earned the RATN title.
- 🐾 **Bitches in season** – BIS may compete at Barn Hunt Trials. They must wear pants and be kept separate from other dogs. BIS will run at the end of their class. Designated walking and crating area will be assigned or must crate out of vehicle. Please inform the trial secretary when you arrive for additional information.
- 🐾 **Height Divisions** – Small (13” and under), Medium (13.1” to 18”), and Large (18.1” and over). Placements are based on height, please have an accurate height recorded.
- 🐾 **Dog Aggression** – Any dog behaving in a threatening or aggressive manner toward another dog or person may be dismissed from the trial if justification found to do so by the judge and/or trial committee.
- 🐾 Dogs must be under control while on trial grounds. All dogs must be on a short leash or crated at all times unless actively working. **RETRACTABLE LEASHES ARE NOT PERMITTED ON PREMISIS.**
- 🐾 **Cancellation Policy** – Every attempt will be made to hold this event as scheduled. In the event of an “Act of God” such as fire, flood, etc., an event may be canceled. We will make every attempt to contact entrants and inform them of the cancellation. We will return all or part of the entry fees at our discretion.
- 🐾 **Withdrawals/Refunds**
 - **Before closing date** - If a competitor withdraws before the closing date, a refund will be issued, less any processing fees, within 5 days after the trial.
 - **After closing date** - Refunds may be given after the closing date, *only* if a wait list has been started and the runs are replaced by a dog on the wait list. If a refund is warranted, one will be issued, less any processing fees, within 5 days after the trial.
 - **Withdrawal due to dog injury or illness** - Refunds may only be given for dog illness or dog injury **with** a note from a Veterinarian. Notes must be presented before trial begins. A refund will be issued, less any processing fees, within 5 days after the trial.
- 🐾 **Waitlist** – When maximum run limit or maximum time limit is reached, a wait list will be started. If the runs are replaced by a dog on the wait list, a refund will be given. If a refund is warranted, one will be issued, less any processing fees, within 5 days after the trial.
- 🐾 **Move ups** – allowed day to day.
- 🐾 **Ribbons and Awards** – Brown flat ribbons will be awarded for all regular class, qualifying runs. Instinct Title ribbons are brown flat ribbons and will be awarded for a dogs 1st qualifying Instinct run. Specific brown flat ribbons will be awarded to dogs with a positive score in Crazy 8s. Placement rosettes will be awarded for 1st thru 4th place. High in Class rosettes may be dated and themed for each trial. For B Classes, the HIC will be in lieu of the 1st place rosette. New Titles awards will be given to dogs with 3 qualifiers in Novice A, Open A, and Senior A; dogs with 5 qualifiers in Master A; and dogs with 10 qualifiers in Novice B, Open B, Senior B, and Master B. New Title awards for regular classes will be rosettes, larger rosette ribbons will be awarded for a RATCH. New Title awards for Crazy 8s will be neck medallions. Specialty awards may be offered at this event.
- 🐾 **Ribbon Presentation** – Results will be announced shortly after each class. Ribbons will then be placed on the ribbon display table to be picked up. Please allow the secretary sufficient time to input and calculate results. If you find yourself waiting around for your ribbons, help out in the ring while you wait. Results are tabulated at the end of the 2nd trial of each class.
- 🐾 **Food** – Lunch will be available onsite for purchase. Snacks and cold beverages also available.

Trial Grounds

- This trial will be held at the Shining Light and Farm Homestead. This is a working farm, please be respectful of the resident animals and home. Please respect any postings on the property.
- There will be a porta potty on site.
- Please do not arrive before 7:45 AM.
- Please dress for the weather. We will run rain or shine.
- **Crating area** – Please check in with the trial secretary for the designated crating area information. Crating will be outdoors and/or out of vehicles. Large grounds to set up crating outside. You are welcome to bring a pop up to provide shade.
- **Parking** is free for this event. Please park in designated area. Handicap parking is available.
- **Smoking/Vaping** is not permitted within 50 feet of any straw, in the building or within 50 feet of the doorways.
- **Ring** – Concrete floor, covered barn, combination of barn walls and 4’ lattice fence panels. One pole inside the ring.

- **Blind** – outdoors under pop-up, minimum 10' x 10' area, maximum 5 dogs in blind.

BHA Waiver and Statement of Vaccination:

This waiver must be signed at or immediately prior to the event. Attendees must check one of the two top boxes, and sign the waiver. Waiver should be printed and presented at check-in. Do not send in with your entry.

I am a fully vaccinated individual 2 weeks post final dose or have provided a negative PCR test within 72 hours of event. I am willing and able to produce documentation of vaccination status upon request. If unwilling/unable to produce documentation/proof, I understand that I must mask in accordance to the COVID-19 rules or will be dismissed from the Event, subject to a misconduct hearing, and possible suspension or dismissal from Barn Hunt.

I have not been vaccinated against COVID 19 or am unwilling/unable to provide proof of vaccination status. I will wear a mask and follow all Barn Hunt COVID-19 rules in the designated Barn Hunt area at all times. I certify that I do not, to my knowledge, have COVID-19 at the time of attending this event, nor have I knowingly been in contact with or exposed to any person with COVID-19 within the past 10 days. I have not been told to isolate or quarantine. I am not awaiting the results of a COVID test. If I have been diagnosed with the virus or have had virus-like symptoms but no formal diagnosis, I certify that I have been released by government officials and/or my health care providers to resume all activity with no limit, and can produce results from a positive antibody test on request, or have had no symptoms for a minimum of 10 days prior to the Event. I understand that I have entered and am competing at this Barn Hunt event entirely at my own risk and take full responsibility for my own health and safety during this Event. I pledge to follow all Barn Hunt Association and specific Club Event rules and requirements to mitigate any possibility of infecting others or becoming infected.
