Canine Adventures reserves the right to remove any individual for any reason from the premises. No refunds will be issued. Please pack food and water for you and your dog. There will be a porta potty on site available.

Notice to Exhibitors:

- 🐾 Will run rain or shine.
- 🐾 Entry fees are non-refundable.
- 🐾 No refunds will be made for cancellations after the closing date or entries which are absent, disqualified, excused or barred from competition by decision of the Trial Committee.
- 🐾 Exhibitors are responsible for complete, accurate and legible information on their entry forms.
- 🐾 It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site.
