**Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run at the end of their class/trial.** Entry fees for bitches that come into season will be refunded until day of the trial if you wish to withdraw. If you are bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing.

# Dog Aggression:

Awards: Ribbons will be awarded for all qualifiers in the regular

classes and the Instinct test. Special Sponsored ribbons will also be awarded.

## **Refunds**:
